

LOCATION RELEASE FORM

I, Prof. Cristina Giacoma ("Representative of Owner") for good and valuable consideration, the receipt and sufficiency of which is acknowledged, hereby grant to PLIMSOLL PRODUCTIONS ("Producer") and its respective parents, subsidiaries, affiliates, licensees, successors and assigns permission to enter upon and use the property, its contents appurtenances located at Department of Life Sciences and Systems Biology (DBIOS), Turin University (the "Property") for the purposes of photographing and recording sequences about Alcon blue butterflies in connection with the production of the program currently entitled, SUPERNATURAL PLANET for NGC Network International, LLC and/or NGC Network US, LLC ("NGC"). Owner grants to the Producer all rights in and to the Materials including without limitation the right to exploit the Material throughout the world, an unlimited number of times, in perpetuity in any and all media, including interactive delivery, now known or hereafter invented and in connection with the Program, Producers use and for advertising and promotional purposes in connection therewith. All rights in the Materials, including copyright, shall be vested in Producer and neither the Owner, nor any tenant, nor other party having an interest in the Property, shall have any claim or right of action (including any claim for injunctive relief and/or money damages) against Producer or any other party arising out of any use of the Materials.

The undersigned acknowledges that Producer is photographing and recording such scenes in express reliance upon the foregoing. The undersigned represents and warrants that the undersigned has all rights and authority to enter into this agreement and to grant the rights granted hereunder and indemnifies Producer from any breach thereof.

Producer is not obligated to actually use the Property or include the Materials in the program and is not obligated to give the Owner notice of such election.



Owner agrees not to issue any press releases or other public statements, including but not limited to, speaking to the press about Owner's involvement or regarding NGC's or Producer's involvement in the Program without Producer's and/or NGC's respective prior written permission. Owner agrees not to use NGC's name, logo, trademark or other proprietary mark in any manner without NGC's prior written approval.

This is the entire agreement. No other authorization is necessary to enable Producer to use the Property for the purpose here in contemplated.
